(3) In the 2007 resolution, the System obtained approval to issue a total of \$23,000,000 in general obligation debt. At this time, only \$14,000,000 of this debt has been issued with a balance of \$9,000,000 to be issued at the School System's discretion.

(4) In the 2015 resolution, the System obtained approval to issue a total of \$20,500,000 in general obligation debt. At this time, only \$13,370,000 of this debt has been issued with a balance of \$7,130,000 to be issued at the System's discretion.

(5) In the 2023 resolution, the System obtained approval to issue a total of \$62,300,000 in general obligation debt. At this time, only \$46,400,000 of this debt has been issued with a balance of \$15,900,000 to be issued at the System's discretion.
